Board Meeting Highlights

The Board of Trustees for the Ark Valley Electric Cooperative Association held its regular meeting for the month of March on March 27, 2023.

Jackie Holmberg, General Manager, presented the CPA audit prepared by Kelso

Lynch, P.C., P.A., which was mailed to the Trustees in the Board packet. The audit results consisted of two documents:



the Financial Statement and Report to the Board of Trustees. The audit covered the financial activity from December 31, 2021 to December 31, 2022. The auditor issued an unmodified report and identified no material weaknesses or significant deficiencies, which is the best designation available.

After reviewing the results of a costof-service (COS) study performed by Power System Engineering (PSE) at the February regular meeting, the Board instructed Cooperative staff to work with PSE to develop more options that would



fairly address demand costs. Possible rate structures incorporating a time-of-use peak demand charge were presented at the March regular meeting. Utilizing a time-ofuse rate structure would be a shift in how the Cooperative's electricity has traditionally been charged, but doing so would more fairly capture the costs associated with producing electricity during peak demand hours. Several usage scenarios were presented to the Board, which showed a general trend that residential customers' winter bills would decrease while their summer bills would increase. However, in such instances customers could lower their summer bills by lowering electric usage during peak demand hours of 3:01pm to 6:00pm. No action was taken, as this item will continue to be discussed at future Board meetings.

Managing Energy Use During Peak Hours

If you look around your home, you likely have more devices and equipment that require electricity than ever before. Our connected lives are increasingly dependent on more electricity. As demand for electricity rises and fluctuates throughout the day, Ark Valley Electric must be able to provide enough electricity to meet the needs of all members during times of highest energy use or "peak hours" — regardless of market conditions or other circumstances.

During those peak hours, which typically occur on the hottest days during the summer months, the cooperative pays more for electricity when cooling systems need to operate longer to cool homes. The peak hours time frame that members should be aware of occurs from 3:00 p.m. to 6:00 p.m., June through September, and excludes weekends and holidays. Members can reduce their bill if they consistently manage their energy use during the peak time frames.

If the peak times concept is a bit confusing, here's another way to think about it. Imagine it being similar to a major concert. We know costs go up when there is strong demand for tickets (or electricity), and both are subject to the basic economic laws of supply and demand. When a lot of people want the same thing, it's more expensive. When they don't, it's cheaper—like a bargain matinee or an early bird special at a restaurant.

During peak periods when the cost to produce and purchase power is higher, we encourage you to take simple steps to save energy, such as turning off unnecessary lights and waiting to use large appliances during off-peak times. When we all work together to reduce energy use during periods of high electricity demand, we can relieve pressure on the grid and save a little money along the way.

Another benefit of this time-of-use approach to electricity use allows greater control over your bill and reduces the power-supply peak demand cost which in turn impacts every co-op member.
